



Utility Contractor Accreditation Program Application

Annual Accreditation Flat Fee is charged per number of employees working for the applicant company. If the applicant is a portion, region, or division of a company, only that applicant entity may be accredited. Employee number is calculated by counting all employees working in vegetation management production and vegetation management support (admin; sales; fleet; shop; etc.) for the applicant entity.
